As a result, an eligible taxpayer who gives a scholarship donation to Aspiring Scholars can claim a 95% credit. A donor must be required to file a Louisiana tax return; Aspiring Scholars is not responsible for verifying donor eligibility. Credits are nonrefundable, but any credit earned in excess of annual tax liability can be carried forward for up to three tax years.
